Fuels Treatment Overview Recommended Treatment Area WC004 Wildcat Canyon Regional Park



Background: In 2010, the East Bay Regional Park District's Board of Directors approved the *Wildfire Hazard Reduction and Resource Management Plan* ("Plan") and the accompanying CEQA (California Environmental Quality Act) document which covers hill and shoreline parklands from Richmond to Castro Valley within the Measure CC (Measure FF) funded area. The approved Plan is an integral component of the Park District's Safe and Healthy Forests initiative for wildfire protection. This project is within Recommended Treatment Area WC0004 of the Plan.




- Why:The purpose of this project is to establish a zone of natural habitat that is resistant to wildfires,
more accessible for firefighters, and less fire-prone. Hazardous wildland vegetation will be
reduced in the wildland-urban interface. Trees and other vegetation will be thinned out or
removed throughout the project on Park District property. Healthy native oak and bay trees will
be preserved where feasible. Some of the logs and branches will be chipped or dispersed onsite,
some will be completely removed, and some material will be left in piles to be burned during the
rainy season. The work is prescribed by FEMA and fully permitted by State and Federal
environmental regulatory agencies. Homeowners should continue to clear vegetation on their
own property and take appropriate measures to protect their homes against wildfire.
- <u>Who</u>: The Park District's Fire Department is managing the project. The Solano Conservation Corps will be performing the initial work, utilizing hand crews only. The Park District's Stewardship Department and consulting biologists will be closely monitoring to ensure appropriate resource protection. The Park District's survey department may be surveying and marking some of the property boundaries to help us make sure we perform work on District lands.
- <u>When</u>: A California Conservation Corps Crew from Solano will begin brush and ladder fuels removal on March 6th, 2023, and will work for approximately three (3) weeks. The Park District and its contractors will minimize the impact to park users by restricting work hours to weekdays (7:30 am to 5:00 pm) and temporarily redirecting trail use, if necessary. This project should not affect any trails.
