

## **EAST BAY REGIONAL PARK DISTRICT NOTICE OF ELECTION**

Notice is hereby given, pursuant to the provisions of California Public Resources Code section 5529 and California Elections Code section 12112, that a general district election to be consolidated with the Statewide General Election will be held in the East Bay Regional Park District (Park District) on Tuesday, November 5, 2024, to choose a successor for three (3) offices of the Board of Directors to be elected in Wards 1, 2, and 4 of the Park District each for a full term of four (4) years.

Generally, the wards include the following areas:

- One from Ward 1, which comprises the election precincts of Albany, a portion of Berkeley, El Cerrito, a portion of Emeryville, Hercules, a portion of Oakland, a portion of Orinda, a portion of Pinole, Richmond, San Pablo, Bayview-Montalvin, East Richmond Heights, El Sobrante, Kensington, North Richmond, Rollingwood, and Tara Hills. This ward is within Alameda and Contra Costa County.
- One from Ward 2, which comprises the election precincts of Alameda, a portion of Berkeley, a portion of Emeryville, a portion of Lafayette, Moraga, a portion of Oakland, a portion of Orinda, Piedmont, a portion of Pleasant Hill, a portion of Walnut Creek, Acalanes Ridge, Alamo, Castle Hill, a portion of Reliez Valley, Saranap, and Waldon. This ward is within Alameda and Contra Costa County.
- One from Ward 4, which comprises the election precincts of Alameda, a portion of Hayward, a portion of Oakland, San Leandro, a portion of Ashland, a portion of Castro Valley, Cherryland, and a portion of San Lorenzo. This ward is within Alameda, County.

The qualifications required for each office for which the candidates are nominated are:

**Each director shall be a resident and a registered voter in the ward from which he or she is nominated. A nomination paper containing the name of the candidate to be nominated shall be signed by at least 50 voters residing within the ward.** (Public Resources Code § 5531)

Official nominating petitions for eligible candidates desiring to file for any of the elective offices shall be obtained from the Alameda County Registrar of Voters (1225 Fallon Street, Room G-1, Oakland, California 94612), or the Elections Officer of Contra Costa County (555 Escobar Street, Martinez, California 94553), on or after July 15, 2024, and must be filed not later than 5:00 pm, August 9, 2024.

If nomination papers are not filed by the incumbent by the August 9, 2024 deadline, any qualified person, other than the incumbent, will have until 5:00 p.m., August 14, 2024, to file nomination papers.

If no one or only one person is nominated for an elective office, appointment to the elective office may be made as prescribed by law.

Polls will be open between the hours of 7:00 a.m. and 8:00 p.m.

The Board of Supervisors of Alameda and Contra Costa counties are hereby authorized and requested to canvass the returns of the Park District and certify the results to the Park District.
